Ken Andrews spoke about the role that Robbie had played over the years. Ken had known Robbie for over 30 years having originally met him in Middlesex. He had been involved with the Age Grade Governance at the RFU , Involved with Lancashire County U18 as a Selector and Coach and was also involved in the North West Regional Pathway. Now retired from teaching he continued to be involved and numbers were currently growing under his guidance.

Ian Spivey

Mark Downs spoke about Ian 's role in the County.

'Ian was originally a long serving County Rep for his club , Aldwinians and for many years before becoming involved in Age Grade Rugby in 2011 – that's minis and Juniors to you and me. He became Chair of the Age Grade Subcommittee in 2013 and has remained constant through the changes our Governing body have made in that time. During this period our Age Grade Competitions have shown growth in the number of teams entering.

Ian has worked with Robbie and John O Ryan to strengthen the Age Grade Rugby and Schools partnership. He is our County lead for the Age Grade Calendar which is a task to bring all our sections including Colts, DPP, Girls and Representative sides to harmony

Ian is the Chairman of the ADM Leagues and sits on the adult Competitions sub committee. He is focusing on the Girls Junior Competitions and is a great help to his long serving Secretary, Christine, on Safeguarding issues.

If his after dinner speeches are as long as his telephone calls many clubs are in for a tortuous evening! Ladies and Gentleman I commend Ian Spivey to you '

Stephen Godfrey

Howard Hughes introduced Stephen to everyone. Stephen began his 'career' in Berkshire working with them and the South West Counties starting at Loughborough in 1972. He had been involved in the England U23 squad. He moved to work at Arnold school where he then became involved in the North U15. He was also club coach at Fleetwood for a time before becoming involved in the Schools Committee, the North Division and is currently a Schools Committee member.

Dave Clarke spoke about the Lancashire Cup Competitions. Letters had gone out to the clubs asking for them to enter. He had phoned all the Senior clubs to ask about them entering the Lancashire Cup Competition but with little success. There was a decision to be made as to whether to move the Cup Competition down a level as only two clubs appeared interested in entering. Currently waiting for an update about which clubs had entered the Competitions. Rohan Whittle asked if the names of the clubs could be publicised to see who had entered

There was then a query regarding the Regulations from the Colts, Brian Stott explained the Regulations had been passed and accepted. Guidance would be issued to clubs to ensure that there was no ambiguity. The Regulations had to be in line with the RFU Regulations. All the Regulations discussed and voted on would be in the guidance.

DC spoke briefly about the RFU Update that had been issued and asked for people's views on Lower XV s in the Leagues. MD will send out a note asking clubs for their views , if 6 clubs reply Yes then there will have to be a more formal County Vote but if not then we will carry on as we are. At the last ask 92% clubs did not want Lower XV s in the Leagues. Other Counties may want them but Lancashire can still refuse.

The review of the Papa John Cup had now taken place. It will be changed to a knock out Competition. 6 dates to be set out, H/A aggregate score then SF then Final.

PH asked for clarification on point 8:1 on the Council 'handout' It was not the intention to affect the CB but the fine detail had not been discussed but it was expected that the CB would carry on as we do.
