To Rugby, both our Senior Mens and Womens XVs sadly came unstuck by Yorkshire in the double header. Sadly, this last line was left in from last seasons report. The Womens XV lost to Staffordshire very closely in the opening game and beat Northumberland on the road. in the opening game with the men winning their only other game in the North group against Somerset!

The U20s face Devon in their final at Twickenham, anyone having watched this team knows they re something special and I'm sure many will feature in the Senior XV in seasons to come.

The County Championship season continues to be pushed back later and later to the point it will soon clash with the start of the following season. This has to stop and be brought back in to May. To ask player to potentially play a final a week before the start of pre-season for their clubs is unfair.

The Finances are in good health, but as with everyone, some more funding would never go amiss. This funding is well allocated by the team of Chris Smail, Paul Deakin, Stephen Briers, and Catherine Ryan are thanked for their continued work for the County and ensuring that the limited funds we are given are used wisely.

Ian and Christine Spivey, along with their Mini & Junior team are thanked and hopefully the forthcoming season will grow the seeds sown by them. Organisation of leagues and finals days have been thorough and enjoyed by all who took part.

I pass on my thanks to Malcolm Worsley and his Club & Community Rugby Committee team for the worthy job they have done his season. Malcolm now steps down from the Board at the AGM and I'm sure we would all wish him well. Personally Malcolm, thanks for your guidance over many seasons whilst I have been involved.

Dave Clarke and Paul Deakin are looking after the Counties interests at the maelstrom of Twickenham. The many sub committees and groups they are involved with takes up a lot of their time. On top of this its not been an easy season with much laundry being aired through certain areas of the press.

The U20s well what can I say other than this bit of the annual report was written about 3 days ago after we finished the County Season as U20 County Champions at the Allianz Twickenham. When we held the Trial (71 nominations) back in January we knew we had something special with the final 33 selected. How good was the squad? Well 32 players got on the pitch at some point as we rode our luck on the injury and unavailability fronts but had the luxury of being able to select squads to do a job against each of our opponents thanks to some precise work from the coaching staff.

Lead Coach Chris Johnson assisted by Jack Weare and Mark Dickinson became a "Holy Trinity" of a coaching team further assisted by two current players as part of their Coaching Development in the shape of Alex Gaughan and Theo Hulbert. Physio Hayley Sumner was fantastic in sticking people back together and always with a smile.

Team Manager **Richard "Dicky" Buckley** has given eight years of solid management for the U20s and ended his tenure with the ultimate prize. I could use all kinds of superlatives for Richard, but I think one proper Wigan word will do, he was "Beltin"

As for the Squad, well it was never easy picking a Match Day 23 when all 33 deserved a spot. However, we managed to select those who we thought had the best chance to deliver our game plan game by game. The nett result for that was just over 300 points scored in the Six games played and the Jason Leonard U20 Trophy sitting in front of you at the County AGM. With so much talent available it was inevitable that we would provide a substantial number of players to the North Division U20s Trial. Depends on how you think "substantial" is in terms of the numbers, but we provided 17 or the 35 players trialling. In the end the final 23 players selected for the North U20 Squad has 12 Lancastrians

in it! That means both myself and those lads selected our season won't finish until the first weekend in July! Nothing can take away from our performances this season we have been outstanding, and the squad buy in was a joy to see. Going back to the "Holy Trinity" the amount of detailed planning and assessment done by Johnno and the guys was some of the best I've seen since my time with England U18s. The lads practically knew what the opposition had had for breakfast thanks to the details relayed in a never-ending stream of analysis provided to them. Not that the coaches did all the work the players were challenged to do some homework, and they did that with aplomb.

I feel quite sure that whilst winning the Trophy was a great achievement for us as a County, the bigger one for me is that all of these players want to wear the Red and White shirt again at Senior Level because they played for each other and the Shirt and they loved every minute of it.

## Regional League 1 North West

## Regional League 2 North East

Rochdale transferred into Yorkshire to balance up the numbers won this League convincingly having led for much of the season. They clinched the League Title with a comfortable win over the early League leaders Bradford Salem in the penultimate match of the season.

#### **Counties 1 ADM Lancashire and Cheshire**

This League again was led by most of the season by West Pk St Helens and despite being pushed hard late on by Didsbury Toc H and Tarleton, they won the League title with an away win at Didsbury Toc H on the last day of the season.

## **Counties 2 ADM Lancashire and Cheshire**

This League was hotly contested by four or five clubs in the early rounds, however after topping the table in late September Wigan went 15 games unbeaten to clinch the title with a convincing win at home to Bolton on the penultimate Saturday of the season.

## Papa John's Community Cup

This season's competition proved to be problematic with cry offs. There were some notable performances, Rochdale reaching the Semi Final of the Regional 2 Championship before losing away at Lutterworth. Also Littleborough reached the quarter Final of the Counties 2 Championship before losing away at Dinnington.

We did have some success at Counties 2 Level with Southport beating Colville in the North Plate Final 47 -26. Thornton Cleveleys won the Counties 2 North Shield Final beating Birmingham and Solihull 25 - 18

Further to criticism received at the roadshows regarding the Papa John's Cup the RFU Competitions Committee undertook a review of the Competition. The result of this is noted below:

## Proposed Regional 1 and 2

National Cup Competition to be scrapped and replaced by a play off system. The intention of this is to provide greater interest until the end of the season and give extra promotion places. This is to be ratified through a series of webinars wit the clubs on the 9<sup>th</sup>, 10<sup>th</sup> and 11<sup>th</sup> June 2025.

#### Counties 1 and Below

There will continue to be a National Cup , however , clubs have been consulted and the majority voted in favour of the first three rounds being played in the regular season and the QF , SF and Final being played in the first three weeks of May. This will allow for more League fixtures in late March and April which historically brings greater revenue for our clubs in the better weather.

There is now a new process for recording incidents and all concerns relating to Safeguarding and discipline.

Incidents are required to be reported firstly to Twickenham for recording purposes. Twickenham will then triage and issue actions to the relevant officers, clubs or investigators. Please ensure this new process is adhered to, it will protect us all. No issues will slip through net, be dealt with in house, nor will any perpetrator go unpunished. This way we will keep all children and adults at risk SAFE. So too our county rugby.

I wish to sincerely thank the 60+ club safeguarding officers who are integral and present in all our County Clubs; (which have under 18 year olds playing rugby and some clubs who don't but still have CSO's).

Without these wonderful and valuable members of clubs and committees, your clubs would and could not function.

It is a regulation from RFU that a CSO is in post, fully trained and qualified at all clubs. The knowledge and experience of these wonderful officers is vast; we are extremely lucky to have them working for us. Sometimes unseen and underappreciated. Here is the opportunity to say publicly say THANK YOU to you all

Sincere thanks are extended to Bob Wilkinson and Graham Winstanley, CSO's from Clitheroe and Orrell respectively, who are stranding down this year after many years in their role's as CSO at their respective clubs. Thank you, gentlemen.

To those CSO's who will be stepping down (that I am not aware of yet), over the off-season, I thank you most sincerely on behalf of myself and Lancashire Rugby, for your work. For protecting young persons and adults at risk and the safeguarding you have achieved within your own club. You will be missed but I am confident you will hand over to your replacements a safe, happy and well run safeguarding practice.

Child Abuse Safeguarding and the reporting of incidents continue to make headlines. Legal and personal responsibility are at the forefront of tackling offences against children and adults at risk.

We must remain vigilant and continue to promote good practice, reporting and maintain observant practices within our cubs.

The new law relating to POSTION of TRUST is now enforceable through law and is an arrestable

offence and is embedded in regulations.

I again wish to thank all the CSO's and officers at our Lancashire clubs who work tirelessly maintaining and continuing to provide robust and effective safeguarding for Young Persons involved within the game. To keeping them safe, allowing them to be heard and acting upon concerns. To those newly appointed CSO's welcome, it's great to have you on board. Welcome to the role, it is an exciting, challenging, so worthwhile but a necessary role.

Finally Thank you to Lancashire CB who continue to be supportive of and acknowledge the importance of Safeguarding Children, Young People in Lancashire Rugby Union.

## MANCHESTER & DISTRICT REFEREES SOCIETY

We are pleased to report that the Society has continued to flourish with 146 active referees, slightly improving on the number for last season, recruiting 39 whilst 15 have retired or moved elsewhere. I am pleased to be able to say that our number of Female Match Officials (FMO's) has increased this season, including 3 female YMO's.

Our Starting to Whistle Course has again proved successful and developed to become more effective; it has a more practical element and the timings for the course have been adjusted, which has allowed us to include listening in to a level 6 referee on a live game with the result that a greater percentage of participants are joining. Following on from Starting to Whistle a new course has been created, the Developing the Referee Programme which had its first run in February/March of this season. Feedback was very positive and we indeed to run it next year.

Red cards went up this to 132, from 83 in 23/24 and 116 in season 22/23. but abuse continues to grow sadly, with some 29 adults MOA red cards and 9 age grade MOA red cards. We are seeing an increase in MOA from coaches, spectators or parents. The positive aspect is that the number of Age Grade players sent off for MOA is decreasing.

We received requests to make a total of 2,152 appointments through the season (2517 in 2023/24).

Two games this season were abandoned at the referee's request, in one case for the purpose of safety as the referee could not guarantee the safety of players due to violent conduct from both sides.

We are aware of two cases which are currently legal matters involving the police and/or the law courts.

Success with the Young Match Officials (YMO) has seen 5 new recruits and two progressing to senior matches before reaching 18 and being supported by the development squad. This is a result not only of their dedication but to the support given by the YMO Officer and the schools; Manchester Grammar, Stockport Grammar, Cheadle Hulme and Lancaster Grammar and our thanks go to all of them.

We continue to support our local Universities and ran a S2W course at the Armitage Centre in December 2024 and another one is planned for this October. This is open to anyone, especially students where we recruit 3-4 each year, whilst others referee the university intramural games.

The Regional 1 North Match Official Team comprising of Northumberland, Durham, Cumbria, Liverpool and Manchester Societies has expanded to include appointments to Level 5 with additional responsibility for assessing, training and the development of referees at this level.

There is a squad of thirty-seven referees, coaches, assessors and camera operators. Twelve of the referees have been appointed to referee at level 5 (they are not all at level 5), the remainder are being developed to move up. We have two referees who have moved up to the national panel and one who has begun officiating in the Premiership this year.

At level 6 and below every active referee we attempt to watch every referee at least once during the season – we conducted over 300 observations this season.

Our coaches and observers have attended training sessions to ensure that referees are being advised using a common criterion. We are a leading Referees' Society with our record of observing and coaching. We intend to appoint a Coaching coordinator for next season as we move to a more "coaching" approach rather than performance review approach.

Our relationship with clubs continues on a positive note and we are grateful for their support. I am pleased to say we have had only a small number of complaints this season and al three were resolved amicably.

The Society moves ever closer to its 125th anniversary.

## LIVERPOOL & DISTRICT REFEREES SOCIETY

The Liverpool and District Rugby Referees held their Annual General Meeting on 13 May 2025, confirming the below under its obligations as a limited business. The society continues to grow and deliver a strong refereeing service across the CBs we support.

Key Highlights:

Referee Activity: 70 referees active this season; 13 new recruits, with 7 now regularly engaged. Recruitment and onboarding is being led by Chris Higgins.

Appointments: Over 1,100 games covered, despite ongoing player shortages. Named awards issued for referees contributing most across Saturdays, Sundays, and midweek fixtures.

Development: Neil Fallon has been appointed as Training Co-ordinator, with Josh Smith. A refreshed training model will focus on inclusive, practical sessions running monthly August–April. Ben Moore has stood down.

Safeguarding: One member removed under RFU procedures following investigation. Safeguarding remains a priority, and the THINK model is embedded across operations.

Welfare: Referee Welfare Protocol adopted by membership and backed by the Executive Committee, rolling out currently and into season 2025-26.

Grading: A continued focus on physical standards (including Bronco testing) will underpin grading decisions, alongside referee value and commitment.

Naming and Identity: Following a member poll, the organisation will adopt 'Liverpool and District Rugby Referees' as its public-facing name. Legal identity as LADS Ltd is retained, "society" is still an acceptable word but not our core referencing.

Finance: Reserves requirement met; accounts approved. Fees and charges remain unchanged into 25-26 season.

Club of the Year: Ormskirk RFC (Special mention: Sefton RFC)

School of the Year: Merchant Taylors (Special mention: St Anselm's College) The society thanks all clubs and CBs for their ongoing support.

#### Areas of Concern

#### Match Official Abuse

This is proving to be an ongoing problem. Clubs and players are not getting the message that this is unacceptable behaviour. Disciplinary Panels can only "shut the stable door after the horse has bolted." To this end we will be adding additional; sanction for any player sent off for Match Official Abuse.

Only clubs & coaches can stop players verbally abusing referees. They set the standards at training and match days.

We will be sending out a new strategy before the start of next season. This will hold clubs more responsible for the actions of their players, officials, and supporters.

## Youth Rugby

We have seen this season a growing number of complaints about the behaviour of coaches and parents. This includes verbal abuse of referees, opposition coaches and opposition players. We have also received complaints of parents entering the field of play and making physical contact with opposition player.

This behaviour is unacceptable, and clubs must act as it does not set a good example to young players.

Should any club require assistance in dealing with any disciplinary issues please contact me and we will be able to give a presentation to support your efforts.

Thanks to all involved at Widnes & Heaton Moor clubs for hosting the finals and for all the hard work that goes into making these days successful and memorable.

National U18s Cup In total 10 Northwest Colts League sides took up a spot in the competition - 3 Lancashire sides- Leigh, Ormskirk & Vale of Lune, were joined by 5 Cheshire, 1 Cumbria, 1 Shropshire. Northwest Colts League side Whitchurch won through the rounds to the semi-final losing out 18-22 to Olney who went on to win the competition. The National Cup entries impacted on the NW Colts League season meaning postponement & re-arrangement of numerous fixtures, these rearrangements combined with weather postponements meant that the League season was not concluded until the 13th April.

**Squad Numbers during the 2024/25 season** - The information taken from the match cards indicate that most sides that manged to play through the season were able to maintain an in some clubs build their player numbers, however, the reasons why 13 sides dropping out either before the season got underway or during the season needs to be assessed.

**Electronic Match Cards (EMC's)** – The Northwest colts league and the Lancashire Cup competitions both introduced EMCs this season. Once a few early issues were sorted they have generally been very successful and easier for team managers /administrators.

Halbro Northwest Colts League Rugby for this coming season - Entries are in for the 2025/26 season - the leagues will be set with 62 sides (6 fewer than last season, but 6 more than the season before that)

- Lancashire have 35 of the 62 sides.
- Cheshire are at 19, Cumbria 4, Shropshire 3 & 1 side from Staffordshire.

There are no combined sides from Lancashire playing in the league this coming season.

**Proposed Lancashire Jnr Colts League** – Howard Hughes (Lancashire CBs' Director of Rugby Development) had made a proposal for a Lancashire only Junior (U17s) League for the upcoming 2025 /26 season.

In a recent meeting between the CB, the RFU & the NW Colts League this proposal was discussed and with little interest from the sides coming through to Colts it will not be going ahead this season.

Changes /Challenges. The over lapping of the Rugby Union & Rugby League seasons continues to raise challenges issues for our Lancashire clubs in Rugby League areas adversely impacting player availability. The timing of the CB U18's Sundays does not help with this matter, in that no sooner has the Rugby League season finished then the CB Sundays begin. The block on playing Colts League fixtures on these CB Sundays hampers sides from gathering any momentum. This is currently being investigated by the CBs and the NW Colts League Organisers.
